Introduction

The **#DIBSummerVibes Contest** (the “**Promotion**”) is organised by Dubai Islamic Bank (in such capacity, the “DIB”, which expression shall be deemed to include its respective successors, transferees and assigns), P.O. Box 1080, Dubai, United Arab Emirates; the “**Organiser**”).

Persons participating or seeking to participate in the Promotion shall each be referred to as “**you**” or “**entrant**” and collectively as “**entrants**”.

These general terms and conditions, as well as any other specific Promotion terms and conditions as notified to you by the Organizer (collectively “**Official Rules**”), apply to this Promotion. By entering the Promotion, you accept and agree to be bound by the Official Rules.

Who May Enter

This Promotion is open to legal residents of the United Arab Emirates only, who are 21 years of age or older at the time of entry in the Promotion.

Employees, officers, directors, agents, representatives and independent contractors (and their immediate family members and members of the same households (whether related or not)) of the Organiser or its, subsidiaries and affiliated companies are not eligible to participate.

The Promotion is void in countries where it is prohibited by law or restricted by such laws, including but not limited to jurisdictions with laws that would require registration and/or trust account or posting of a bond, or any other requirements that have not been satisfied.

Subject Matter of Entries

- vi. contains any personal identification, such as license plate numbers, personal names, e-mail addresses or street addresses
- vii. contains copyrighted materials owned by others (including photographs, sculptures, paintings, and other works of art or images published on or in websites, television, movies or other media), without permission
- viii. contains materials embodying the names, likenesses, or other indicia identifying any person, including, without limitation, UAE ruling family, government officials, celebrities and/or other public or private figures, living or dead, without permission
- ix. contains look-alikes of celebrities or other public or private figures, living or dead
- x. communicates messages or images inconsistent with the Sharia principles and/or good will to which the Organiser wishes to associate; and/or
- xi. violates any law of the United Arab Emirates, custom, usage, principles of Sharia and the public policy.

Entry must be the original work of the entrant and must not infringe upon the copyrights, trademarks, rights of privacy, publicity or other intellectual property or other rights of any person or entity. If the Entry contains any material or elements that are not owned by the entrant, and/or which are subject to the rights of third parties, the entrant is responsible for obtaining, prior to submission of the Entry, any and all releases and consents necessary to permit the use and exhibition of the Entry by Organiser in the manner set forth in these Official Rules, including, without limitation, name and likeness permissions from any person who appears in or is identifiable in the Entry.

If any minor appearing in the photo is not the child or legal ward of the entrant, entrant is responsible for obtaining written consent from such minor's parent or legal guardian prior to submitting his/her Entry into this Contest.

Organiser reserves the right to request proof of these permissions in a form acceptable to Organiser from any entrant at any time.

By submitting an Entry, entrant hereby grants permission for the Entry to be posted in the "#DIBSummerVibes Social Media Contest" Gallery and/or other websites of the Organiser. Entrant agrees that Organiser is not responsible for any unauthorized use of Entries by third parties.

Organiser does not guarantee the posting of any Entry. By submitting an Entry, entrant acknowledges and agrees that Organiser may obtain other Entries under this Contest or have developed on its own through other third parties ideas and material that may be similar or identical to the Entry submitted by entrant, and entrant waives any and all claims he/she may

have had, may have, and/or may have in the future, that any other Entry reviewed and/or used by Organiser may be similar to his/her Entry.

Release of Liability

Unlawful Conduct and Disqualification



Organiser reserves the right, in its sole discretion, to disqualify any Promotion participant whom the Organiser determines, in its sole discretion, has (a) tampered with the entry process or the operation of the Promotion or of any web site owned, operated or controlled by the Organiser or its respective subsidiaries or affiliated companies; (b) was ineligible to participate in the Promotion; (c) submitted more than the allowed number of entries; or (d) otherwise acted in an unlawful manner and/or in violation of these Official Rules. Robotic, automated, programmed, or computer generated entries or mechanical reproductions are prohibited, and any use of such devices or entry methods will cause disqualification. Any attempt by a participant to deliberately damage any web site or undermine the legitimate operations of the Promotion is a violation of criminal and civil laws. Should such an attempt be made, Organiser reserves the right to seek damages from any such participant to the fullest extent permitted by law and to disqualify such participant from the Promotion.

Limitation of Damages

UNDER NO CIRCUMSTANCES, INCLUDING NEGLIGENCE, SHALL ORGANISER/DIB OR RELEASED PARTIES BE LIABLE FOR ANY DIRECT, INCIDENTAL, INDIRECT, SPECIAL OR CONSEQUENTIAL DAMAGES, OR EXEMPLARY OR PUNITIVE DAMAGES, INCLUDING, BUT NOT LIMITED TO LOSS OF PROFITS OR HARM TO BUSINESS OR REPUTATION, ARISING OUT OF ENTRANT'S PARTICIPATION IN THE PROMOTION, USE OF ANY PHOTO OR DESCRIPTION PROVIDED BY ENTRANT, POSTING ON OR ACCESS AND/OR DOWNLOAD OF ANY MATERIALS OR INFORMATION FROM ANY WEB SITE OWNED, OPERATED OR CONTROLLED BY ORGANISER, OR ACCEPTANCE OR USAGE OF THE PRIZE, INCLUDING WITHOUT LIMITATION DAMAGE TO PROPERTY AND, TO THE MAXIMUM EXTENT PERMITTED BY LAW, DAMAGES FOR BODILY OR PERSONAL INJURY, EVEN IF ORGANISER HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES OR LOSS. ENTRANT AGREES THAT THE AGGREGATE LIABILITY OF ORGANISER ARISING OUT OF ANY KIND OF CLAIM (WHETHER IN CONTRACT, TORT, OR OTHERWISE) SHALL NOT EXCEED \$1.00.

Amendments

Organiser reserves the right to suspend, cancel, terminate or modify the Promotion without advance notice in the event Organiser believes, in its sole discretion, that any computer virus, worms, bugs, tampering, spamming, unauthorized intervention, fraud, technical failures or other errors or problem beyond the Organiser's control could corrupt or affect the administration, security, fairness, integrity or proper conduct of the Promotion, and thereafter to re-commence





such Promotion, if at all, only at such time(s) and upon such terms and conditions as Organiser shall deem reasonable under the circumstances.

Severability

If any one or more provisions of these Official Rules are held to be invalid, illegal or unenforceable by a court of competent jurisdiction, such invalidity, illegality or unenforceability shall not affect the validity, effect or enforcement of any other provision or provisions of these Official Rules.

Force Majeure

The failure of the Organiser to comply with any provision of this Official Rules due to an act of God, hurricane, war, terrorism, fire, riot, earthquake, actions of governmental authorities outside the control of the Organiser or other force majeure event shall not be considered a breach of these Official Rules.

Personal Data

Personal information collected from entrant in order to conduct the Promotion will be used in accordance with the Organiser's Privacy Policy (available at <http://www.dib.ae/terms-conditions>) or as otherwise set out in these Official Rules. Each entrant expressly consents to the use of his/her personal information for such purpose. The Organiser will not sell, share, or otherwise disclose information collected in any manner with third parties, other than those parties necessary to fulfill the above purposes, unless entrant has given his/her prior express consent to receive additional information from the Organiser or a third party.

Governing Law; Jurisdiction; Venue

These Official Rules shall be governed by the laws of the United Arab Emirates. Entrants agree to submit to the exclusive jurisdiction of the Courts of Dubai. Nevertheless, this shall not restrict DIB from bringing an action against entrants before courts of any other jurisdiction. To the extent allowed by law, DIB may take concurrent proceedings in any number of jurisdictions.
